"AMATEUR KABADDI ASSOCIATION HARYANA"



3. The Society shall carry out Its major activities an jurisdiction in the State of Haryana regarding the Kabaddi Games. The Association shall be affiliated to the Amateur Kabaddi Federation of India. All activities of the Amateur Haryana Kabaddi Association shall be done by the rule-regulations and guidelines/instructions of Amateur Kabaddi Federation of India.

Definitions;

i). "Association" shall mean Amateur Kabaddi Haryana.

- iii). "General Body" means and includes all the voting and non-voting members.
- iv). "District Member" means any of the District Kabaddi Association of State of Haryana, which is an affiliated member of the Association (Revenue District as per Government Rules)
- v). "National Code" means 'National Sport Developent Code of India, 2011, which shall include future amendments by the Government of India.

AIMS & OBJECTIVES

The association shall be the governing body of the game of Kabaddi in the State and its objects shall be to advance and safe guard the interest of the game perticularly

- 1. To promote, organize, manage and control the game of Kabaddi within its jurisdiction at grass root level.
- 2. To select teams to represent the Association in any tournament, championship or fixture, local or otherwise, and to incur and meet the expenses thereof.



3. To arrange proper coaching camps for the benefit of Kabaddi players, to provide suitable coaches and to acquire and maintain play grounds, either directly or through District Kabaddi Associations.
4. To maintain general control over the game of Kabaddi under its Jurisdiction and to take decisions in all matters concerning the game, either when referred to by affiliated associations or suo motu.
5. To acquire by all lawful means movable or immovable properties on behalf of the association, for the development of the game of Kabaddi. To purchase, take on lease or otherwise acquire grounds or buildings and lay out such ground (s) for playing the game of Kabaddi.
6. To collect the funds and to utilize the same as well as the other funds in such manner as may be considered fit for fulfillment of the objects of the Association.
7. To abide by the Rules, regulations and directions be given by the National Federation i.e. Amateur Kabaddi Federation of India for the development of the game or otherwise.
8. The main object of the society/Association to promote and development the Kabaddi in State of Haryana, through district representatives duly elected in the democratic election at district level.
9. To offer competitive opportunities in Kabaddi.
10. To abide by the National Sports Development code 2011.



BYE-LAWS OF THE SOCIETY

1. Membership:

- i). The Association shall have a maximum of 60 members including the founder members/ordinary members representative of Sub -Committee(s).
- ii). **Eligibility:** In order to be admitted as a member of the association, a person:
 - i) Must be 21 years of age on the date of admission;
 - ii) Should subscribe to the aims and objects of the Society/Association.
 - iii) Must have deposited the admission fee and annual subscription fee and must not be in arrears of payment of such fee as in the date of annual general meeting for continuing as a member;
 - iv) Must not be an insolvent and of unsound mind; and
 - v) Must not have been convicted of an offence involving moral turpitude involving imprisonment of one year or more.
- iii). **Kinds/Types/Categories of Members:** The association shall consist of four different categories of members as under:-
 - i) **Founder Members:** A Member who has been admitted as a founder member at the time of registration of the association and has paid the requisite membership fee to the association. The number of founder members shall not exceed seven. The founder members shall also be deemed to have become life members of the association and shall have the privilege of being members of the collegiums without

election, in case the total number of members of the Association exceeds 300.

ii) **Life Members:** A person may be admitted as a life member on payment of the prescribed fees and such person shall continue to be the member of the association for his/her life. The total number of life members shall not exceed 53. If the association be granted the affiliation to Distt. Kabaddi Association in State of Haryana then the President and Secretary of Distt. Kabaddi Association treated as a life member of this society/association.

iii) **Ordinary Member:** The association shall have a total of five ordinary members who shall continue to enjoy their membership only so long as they are not in arrears of payment of their annual subscription fee. An ordinary member may not be admitted as a tenure member, say, for a period of two to five years(s), as the case may be, and he will cease to be a member of the Association on completion of his/her tenure, unless it is renewed by the Governing Body for the another tenure.

iv) **Honorary Member:** The Governing Body may admit individuals of distinguished talent and merit or whose Association is deemed to be beneficial to the Association or who has rendered services of outstanding merit to the Association or who is distinguished citizen of India or any other country as Honorary Member of the Association after obtaining consent of the individual, without payment of fees. The membership shall not exceed five. The Honorary member shall be

entitled to attend the meetings and contribute to the deliberations. but shall have no right to vote.

iv). **Membership Fee & Annual Subscription:**

i). The rate of membership of the association and the annual subscription shall be as under:



ii). The payment of annual subscription of a member shall become due as on the 1st of April of every year, which may be paid latest by the 30th of the June of such year. The membership of a defaulting member shall be deemed to be under suspension after the due date (30th June) and such member shall not be entitled to cast his vote during the elections of the Association held after 1st July of the said year.

iii). The suspension of membership on account of default in payment of the annual subscription may be revoked after he has cleared the default with alongwith 18% Interest amount payable. However, he shall not be eligible to cast his vote in any election held during the remainder of the financial year.

v). **Admission Procedure (For members other than the subscribers):**

i). The admission of a person as a member of the Association shall be decided by its Governing Body from time to time;

ii). An individual willing to be a member of the association has to submit an application in prescribed form, and alongwith supporting document to the General Secretary duly filled in and signed and recommended by a regular member of the association.

iii). The general secretary shall examine the application and place the same before the governing body for a decision.

iv). The governing body may accept or reject the application and the decision of the governing body in this regard shall be final. It shall not be bound to assign any reason for its decision.


v). The approval of the governing body shall be intimated to the member, his name shall be entered in the registrar of members, to be maintained in such manner and form as prescribed under the Haryana Societies Registration Rules, 2012 and he/she will be issued an Identity Card of the Society.

vi). **Identity Card for every member:** every person admitted will be issued an Identity card containing his/her photograph, brief particulars and membership category, duly signed by the individual Member and the General and the General Secretary of the association.


vii). **Right & Obligation of Members:**

- All the members of the association shall be bound by the rules and regulations of the associations as contained in its byelaws and amended from time to time;
- Every member, except an Honorary member, shall have a right to cast his vote at the elections of the association provided such member is not a defaulter in payment of any dues of the society, and

the annual subscription for a period of three months beyond the due date;

- iii). Every member of the association should have the right to inspect the books of the accounts, books containing the minutes of proceedings of the general meetings, meetings of the governing body and register of members of the association on any working day by day giving a notice of seven days;
- iv). Every member shall inform the association about any change in his address, which shall be duly recorded in the register of members of association and upon which the association shall issue a fresh identity card to such member.

viii). **Cessation of Membership:** Any person admitted as a member shall cease to be members of the Association in the following events:

- i). Attracts the provisions contained in section 22 of the Act;
- ii). Upon his/her acting contrary to the aims and objectives of the association.
- iii). Upon such member being found guilty of a financial misappropriation of the funds of the association.
- iv). Upon indictment and directions for removal by the District Registrar/Registrar/Registrar General of Association.
- v). An Honorary member shall cease to be a member of the society, the governing body, decides so by passing a resolution in this behalf.



- i). Every person admitted as a member shall be a member of the general Body of the Association and shall be entitled to cast his vote for the election of the Governing Body of the Association unless he is in arrears of the payment of any dues of the Association, including the annual subscription.
- ii). Every member shall cast his vote in person and no proxy voting shall be allowed.

3. Meeting of the General Body:

- i). A meeting of the general body of the association will be held as and when required. However, at last one meeting of the General Body of the Association, called as the Annual General Meeting (AGM) will be held in a year, Within six months of the close of the financial year for consideration and adoption of the duly audited annual accounts of the Association in addition to transaction of any other business of the Association as may be required.
- ii). The governing body of the Association may convene an extra ordinary meeting of the General body of the Association at any time after giving due notice as prescribed hereunder, either of its own or within 45 days of receipt of a written requisition alongwith reasons for convening such meeting, from at least 1/10th members of the General Body.
- iii). For any meeting of the general body clear notice of Atleast 45 days alongwith a copy of the agenda of the business to be transected time & venue of the meeting Will be given to the members of the General Body. A copy of such notice will also be endorsed to the District Registrar.


- iv). A meeting of the General Body may also be convened at a shorter notice, if agreed to, by a majority (at least above 50% of the total members) of the members of the General Body.
- v). Quorum for the meeting of the General Body will be 40% of the total members entitled to vote and present in person, subject a minimum of four members. In case of a meeting adjourned for want of quorum, the quorum of the adjourned meeting shall not be less than 10% of the total members, subject to a minimum of the three. The General Body shall be competent to transact all business in such adjourned meeting except the consideration of any Special Resolution. Any Special Resolution can be passed in such adjourned meeting only if at least 25% of the total members of the Association are present.
- vi). The proceedings of all meeting of the General Body will be recorded in the minute-book (bound or in loose leaves) maintained separately for the purpose by the General Secretary and such minutes will be signed by the Chairman of the meeting and General Secretary of the Association.

4. Powers, Functions & Duties of the General Body:

- i). To guide the Association in determining and fulfilling its aims and objects.
- ii). To decide policy matters such as change of the name of the Association, amendment in the Memorandum of the Association and the Bye Laws of the Association, approval of annual accounts of the association etc. and such other acts as may be required under the Haryana Registration and Regulation of Societies Act & Rules, 2012.

- iii). To elect the members of the governing body.
- iv). To remove the members from the governing body and according approval to the continuation of a person appointed as a member of the governing body against a casual vacancy.
- v). To ensure strict compliance of the mandate given by the National Federation and the Rules and Regulation of Amateur Kabaddi Federation of India.
- vi). To ensure compliance of the National Sports Development Code 2011 and Rules, Regulations, Circular and guide line issue by the Government of India.

5. Governing Body:


1. Composition:

The governing body of the society shall consist of a total of 21 office-bears and members as under:-


- (a) President
- (b) Vice-President
- (c) General Secretary/Secretary
- (d) Joint Secretary
- (e) Treasurer
- (f) Sixteen Executive Members, including co-option of any Honorary Member by the Governing Body.

6. Election of the Governing Body:

- (i) The terms of the governing body shall be three years from the date of approval of its election by the District registrar;
- (ii) The governing body will declare the schedule of Election and appoint the returning officer for the conduct of elections and also notify/display a list of members of the general body entitled to vote at least 45 days prior to the holding of the general body for conduct of

the elections. The governing body to all the members, conveying the date, time and the manner. The information w.r.t. holding the election for the governing Body shall also be sent to District Registrar to appoint an observer, if he so desires.

(iii) Any objections qua the list of members of members of the Association entitled to vote shall be decided by the Returning Officer in consultation with the office-bearers of the Association. However, the decision of the Returning Officers shall be final in the event of any difference of opinion. The Returning Officer shall, thereafter, invite nominations to be filed within the period prescribed on the Schedule of the election, scrutiny and withdrawal of nominations, if any, for election of the office bearers and the executive members of the Governing Body.

(iv) The Returning Officer will display a list of the contesting members on the notice board of the Association; the returning officer will conduct the election on the notified date. The members eligible to vote will be allowed to cast their vote on person, and whatever disputed, on production of the identity card Issued by the Association.

(v) After closing hours on the date of the poll, the returning officer will declare the results and constitute the Governing Body of the Association. A list of the elected office bearers and the executive members of the Governing Body, duly signed by the Returning Officer will be filed with district registrar within 30 days, who shall accord his approval of the same upon his satisfaction.

(vi) The office bearers of the Association shall not be entitled to any remuneration for rendering to the Association.

7. Filing of any causal vacancy on the governing body:


Any vacancy arising on account of resignation or death of any member of the Governing Body or for any other reason, may be filled-up by the Governing Body, if required, from amongst the members of the General Body on adhoc basis till the holding of next Annual General Meeting, if has appointment is not improved in the Annual General Meeting by a majority vote for the balance term of the Governing Body.

8. Meeting of the Governing Body:


(i) The meeting of the Governing Body will be held as and when required. However, the Governing Body shall meet at least once in every quarter and there will be minimum four meetings of the Governing Body in a financial year.

(ii) A clear notice of three days of every such meeting will be given by the General Secretary of the Governing Body to the office bearers and members before the date appointed for the meeting. However, the Governing body may meet at shorter notice, wherever so required, with the consent of at least fifty percent of its members.

(iii) The quorum of the meeting of the governing body shall be at least 40% of the total members of the governing body shall minimum of 5 members. In case quorum is not present, the meeting shall be adjourned to another date for which proper notice shall be issued, the members present in the adjourned meeting, subject to

a minimum of three members, shall form the quorum for the adjourned meeting.

(iv) The proceedings of every meeting of the Governing Body will be recorded in the proceedings books separately maintained for this purpose. Such minutes shall be signed by the Chairman of the meeting and General Secretary of the Association. In case the Chairman or General Secretary are not available to sign the minutes, this will be signed by any two members present in the meeting as may be authorized by the Governing Body.

(v) The minutes of every meeting of the Governing Body will be placed for confirmation in the succeeding meeting of the Governing Body.

9. Power, Function & duties of the Governing Body:

(i) The Governing Body will be responsible for the achieving the aims & objectives of the Association and shall work in the best Interest of the Association for which it shall be Empowered to deploy the funds & assets of the Association for the stated objectives;

(ii) The Governing Body will be competent to raise funds and purchase property, movable and immovable, on free-hold or lease basis in its name, as decided by it.

(iii) The Governing Body shall have full charge of immovable properties and movable assets belonging to or vested in the Association and these will be managed in such a manner as the Association considers appropriate subject to the overall control and directions of the General Body of the Association.

- (iv) The Governing Body shall be competent to invest the funds in the manners it considers appropriate in the best interests of the Association and it shall competent to borrow or mortgage or hypothecate the properties on behalf of the Association in the manner decided.
- (v) To constitute various standing or adhoc committees for looking after such functions as may be assigned from time to time.
- (vi) To create provision for engagement of regular or part time employees of the Association to look after the secretarial, accounting and other functions in seamless manner.
- (vii) To outsource certain functions e.g. cleaning, security and similar other maintenance activities of the premises of the Association.

10. Powers, Functions & duties of the individual members of the Governing Body:

(i) President:

- (a) To preside over all the meetings of the General Body and regulate the proceedings of such meetings.
- (b) To do all such acts, deeds and things as may be authorized by the General Body and/or the Governing Body from time to time.
- (c) To allow or disallow discussion on any matter which is included in the agenda.
- (d) To ensure proper & transparent functioning of the Association/Governing Body.

(c) To convene meetings of the General Body/Governing Body with the consent of the president and the serve proper notices as prescribed under these byelaws.

(d) To attend all the meetings of the General Body and the Governing Body and assist the president in conducting the meetings and record proceedings of all meetings.

(e) To prepare annual report of the Association and place it before the governing body alongwith audited annual accounts of the association, for approval to place the same before the General Body in the Annual General Meeting.

(f) To keep and preserve the records of the Association/Governing Body.

(g) To help and assist the president in looking after the complete affairs of association and in attaining aims and objects of the association.

(h) To insure timely of all statutory returns/documents on the office of the District Registration and such authorities as may be prescribed under the Haryana Registration and Regulation of Societies Act, 2012 and the rules made there under.

(i) To be custodian for safe custody of common seal of the Association and affix the same, wherever required, as the authorization of the Governing Body.

(j) To conduct correspondence on behalf of the association/governing body and to assign letters and


(k) To prepare before the announcing of the date of election and the Annual General Meeting, the list of all the members eligible to vote, duly updated and to place it before the Governing Body.


(b) To get the accounts of the Association audited by the Chartered Accountant appointed by the Governing Body at the close of the financial year, every year.





14. Management of Assets and Funds of the Association:


(i) The sources of income of the association will include receipts on accounts of membership fee, annual subscription, rent from property/assets, interest, consultation fee, donations, gift, grants etc. The association can also raise funds through interest free short terms loans from its members or from scheduled banks on interest. Loan from the scheduled banks on interest will be taken only for purchase of creation of capital assets and not for meeting any recurring revenue expenditure under any circumstances.

(ii) The governing Body will prepare and approve an annual budget of the association on the basis of its estimated income and the capital & revenue expenditure during the first quarter of the financial year and shall also place a copy thereof before the governing body in its Annual General Meeting for information.

(iii) The bank accounts of the association will be jointly operated by such members/office bearer as may be decided by the governing body from time to time.

(iv) All assets and funds will belong to the association and vest in the association.

(v) All receipts and payments of the association shall be made through Bank Instruments (i.e. DD/Pay Order/cheques/Bank Transfers/RTGS) including all receipts towards the members Fees and the annual subscriptions from the members. However, the governing body may determine the limits of financial

15. Accounts of the Association:


The Association will have a common seal which shall be kept in safe custody of the General Secretary and shall be affixed wherever it is required in accordance with the authorization by the Governing Body.





5. Governing Body :

1. Composition:

The Governing Body means the elected 11 Members Governing Body of Amateur Kabaddi Association Haryana of Haryana Constituted/ Elected under the rules and regulation, Inclusion of prominent sportspersons of outstanding merit as members of the respective sports, Federations on tenure basis. The strength of such prominent sportspersons with voting right should be a certain minimum percentage (25%) of the total members representing the federation. Office bearers and members of Governing Body are as under :

- 1. President**
- 2. Vice President**
- 3. General Secretary/ Secretary**
- 4. Joint Secretary**
- 5. Treasurer**
- 6. Six Executive Members, including co-option of any Honorary Members by the Governing Body.**

6. Election of Governing Body :

(i) The terms of the governing body shall be three years from the date of declaration of election. For the post of President / Secretary any person / Member is eligible to seek election subject to getting his nomination papers duly proposed and seconded by any of the affiliated units. One affiliated unit can propose only one person.

- a. **Tenure for the post of President shall be Maximum of 3 terms of 3 years i.e. Maximum of 9 years with or without breaks.**
- b. **Tenure for the post of General Secretary / Treasurer shall be maximum of 2 consecutive terms of 3 years i.e. maximum of 6 years**

and after a cooling off period of 3 years may be eligible for seeking fresh election for either of the post.

c. The President, General Secretary and Treasurer shall cease to hold the post on attaining the age of 70 Years.

d. Holding of Office – No office-bearer of AKAH will be eligible to be office bearer simultaneously in any other National/ State Sports Federation, excluding Indian / Haryana Olympic Association.

e. This Constitution shall be subject to the overarching requirements, prohibitions and stipulations specified in the National Sports Code (including its subsequent amendments and modifications) and in the event of any inconsistency between this Constitution and the National Sports Code, 2011 the relevant corresponding provision of the National Sports Code shall apply to the extent of such inconsistency. Any provision of this Constitution that is inconsistent with the National Sports Code in its entirety shall be inoperative and deemed to have been deleted from this Constitution.
